An exploratory study of quality of life and psychosocial adjustment among non-affected adults of a family with a child with either acute lymphoblastic or acute myelogenous leukaemia. To compare quality of life in a family with a child with acute lymphoblastic leukaemia (ALL) or acute myelogenous leukaemia (AML) to other cancer patients' families. Exploratory design. Thirty-five families were invited by the paediatric oncology ward of the VU medical centre, in Amsterdam, The Netherlands, to participate in the study. The participants of the ALL-group had been referred to the paediatric oncology ward after the diagnosis of ALL had been established for their child. The AML-group consisted of parents and children from the biological or adopted families of patients who had been referred to the paediatric oncology ward after the diagnosis of AML had been established. A control-group (n = 22) was matched to the AML-group by means of a complex matching algorithm. The administration of the EORTC QLQ-C30 was performed in September 2001, and was repeated in March 2002. No differences were found between the groups with respect to psychosocial adjustment and self-rated health. However, a difference emerged between the ALL-group and the other two groups. Quality of life was lower in the ALL-group than in the other two groups. This study suggests that parents and children of children with ALL have to cope with the problems associated with their child's disease and its treatment during the whole life of their child.
